

LINCOLN SCHOOL DISTRICT 156
PROOF OF RESIDENCY

It is required by law that all students attending Lincoln School District 156 be bona fide residents of the district. To be a bona fide resident, a student must be living with a parent or a court approved resident guardian with legally acceptable custody and control documents. At the time a student is registered, parent/guardian(s) will be required to provide documents, acceptable to the district, showing proof of residency. A Lincoln School representative or a detective agency hired by the district may visit the residence during the year to verify residency.

Any registration of a person who is not a resident, as described above, is an act of misrepresentation, either negligently or fraudulently, and this action costs the district for such unauthorized services to the non-resident student in the approximate amount of or \$. per day. If any of the information submitted to the district to substantiate residency of the student is found in error, then this action is grounds for immediate withdrawal from Lincoln School District 156 and the time spent in the school by the student will be pro-rated and charged to the parent/guardian on the basis of the number of days in attendance at Lincoln School.

THREE (3) SOURCES OF VERIFICATION ARE REQUIRED FOR PROOF OF RESIDENCY AND MUST BE CHECKED BY THE OFFICE. ALL SOURCES MUST INCLUDE PARENT/GUARDIAN'S NAME, ADDRESS AND CURRENT DATE (LESS THAN 30 DAYS OLD). YOU MUST HAVE ONE ITEM FROM CATEGORY 1, ONE ITEM FROM CATEGORY 2, AND ONE ITEM FROM CATEGORY 3 OR 4 TO PROVE RESIDENCY.
